




#### STATE SPENDING LIMIT







#### CAP PFD FOR GENERAL SERVICES









Do you support or oppose enacting a statewide income tax?



Among options for addressing Alaska's fiscal gap, which do you most prefer?








#### **RE-CONSIDER TAX CREDITS**








*Is funding for K-12 education:*
