Senate Committee Unveils "Alaska Education Transformation Act"

A new bill from Alaska Senate leaders would create a virtual education hub for the state, among other provisions aimed at reducing the state's \$1.3 billion in annual schools spending. Sponsored by the Senate Education Committee, chaired by Shelley Hughes, R-Palmer, SB 96 would establish a "virtual education consortium," which would create a database of online courses and help train teachers in virtual instruction.

The bill has several other measures aimed at cutting costs, including one that would increase the size of one-time grants that can be given to school districts joining a state-sponsored plan for health insurance – a major cost driver for schools. House Votes to Create Reading Task Force

The House of Representatives voted Friday to create a task force of educators and legislators to explore solutions to reading deficiencies in Alaska K-12 students. The 15-member group, including three members from each of the House and Senate, is to report to the Legislature next year on its findings. [HB 64](#) passed the House on a vote of 33-3 and now goes to the Senate for its consideration.
