COMMITTEES CHARGE

Develop up to three recommendations that will be transformational in our public education system.

- Be systemic and apply to all students, schools, employees, and communities
- Not require resources beyond our direct control
- Produce measurable results that can be benchmarked against other states and countries.

EVERY STUDENT SUCCEEDS ACT (ESSA)

Federal resources that will help the state to reach the commitments identified Alaska's Education Challenge





ELEMENTARY AND SECONDARY EDUCATION ACT (ESEA)

1965 Elementary and Secondary Education Act (ESEA)

1970 Tightening up the reigns "Supplement not Supplant"

1978 School Wide Title I – 75% or more in poverty

1979-81 Formation of USDOE updates to ESEA – Consolidate programs to single block grant – Cuts down on district and state requirements

1988 Move toward more student accountability and testing - introduction of Adequate Yearly Progress AYP – Schools not making progress had to make a plan
1989 Education Summit – most state governors – set national education goals that fueled a federal- state partnership in standards and accountability

1994 Improving American Schools Act – added pieces to AYP

2002 Reauthorization of ESEA No Child Left Behind Act (NCLB) expanded AYP requirements – addition of teacher qualification –





EVERY STUDENT SUCCEEDS ACT (ESSA)

2015 Reauthorization of ESEA – Every Student Succeeds Act (ESSA) – Alaska's ESSA Plan approved May 2018

- •Title I, Part C
 - •Education of Migratory Children
- •Title I Part D
 - •Neglected, Delinquent or At-Risk Children & Youth
- •Title II, Part A
 - •Supporting Effective Instruction (Quality teachers and School Leaders)
- •Title III, Part A
 - •Language acquisition for English Learners and immigrants
- •Title IV, Part A

•Student support and academic enrichment grants.





GRANTS

- IDEA Title VI-B
 - Services for the identification and support of students with disabilities under IDEA
- IDEA Part B 619
 - Grants for preschool programs for disabled students

Carl Perkins

 Grants for secondary schools to strengthen the academic and career and technical skills of CTE students by improving/expanding/modernizing CTE programs.



ESSA REQUIREMENTS







STANDARDS & ASSESSMENT

- 2012 New Standards adopted in English Language Arts and Mathematics
- State summative assessment Performance Evaluation of Alaska Students (PEAKS) assessed beginning in Spring 2017





ESSA ACCOUNTABILITY REQUIREMENTS

 State-determined accountability system must "meaningfully differentiate" schools

 State must have ambitious statedesigned long-term goals for all students and subgroups





ESSA ACCOUNTABILITY REQUIREMENTS

- Academic achievement as measured by proficiency on annual assessments
- Another measure of academic achievement (such as student growth)
- Graduation rates for high schools
- Progress of English Learners in learning English





SCHOOL DESIGNATION

- Three designations:
 - Comprehensive Supports and Improvement (CSI)
 - Targeted Supports and Improvement (TSI)
 - Universal Supports (US)
- All schools are eligible for a TSI or CSI designation regardless of size. (Small School Review)





CSI DESIGNATION

- Lowest 5% of Title I schools
- Graduation rate < 66 2/3%
- 3 Consecutive Years of a TSI designation for the same subgroups





TSI DESIGNATION

Any one of the nine possible subgroups in a school score within the range of the lowest 5% designated CSI Schools.





ESSA SUBGROUPS

- African American
- Alaska Natives or
 - American Indians
- Asians or Pacific Islanders
- Caucasian

- Economically Disadvantage Students
- English Learners
- Hispanic students
- Students with Disabilities
- Students of Two or More

Races





LONG-TERM GOALS

 Reduce by ½ the % of students not proficient in ELA and Math

• 90% graduation rate (4 year) & 93% (5 year)

• 70% of English learners make progress
