



Terms & Conditions

1. The Association of Alaska School Boards (AASB) is an IRS 501(c)(3) non-profit corporation that **supports school boards in providing quality public education, focused on student achievement through effective local governance, which includes in-person conferences and training opportunities.** In this role, AASB is working with member school districts to provide in-person conferences and training opportunities during the current COVID-19 pandemic. Providing these in-person opportunities during this time cannot be done without inherent risk to all participants. This effort to provide these opportunities (referred to be as the EVENT) comes with inherent risks.
2. In consideration of being permitted to participate in an EVENT, I, for myself and my children, agree to the following:
 - i. I affirm that I am not currently diagnosed with, demonstrate any symptoms of, or have in any way been exposed to any communicable diseases, including the novel coronavirus known as COVID-19.
 - ii. I agree that I will immediately notify AASB I am diagnosed with the novel coronavirus known as COVID-19. I understand that this notification requirement is critical to limit the spread of the virus.
 - iii. I acknowledge that I am aware that by entering any EVENT premises and participating in the EVENT that there are inherent risks of being exposed to COVID-19, and/or any mutation or variation thereof. I am also aware that such an exposure can occur directly or indirectly.
 - iv. I understand that while AASB works with the venue to provide reasonably safe EVENT premises, AASB cannot eliminate all risks.
 - v. By signing this Waiver, I ASSUME ALL RISKS regarding the possibility of contracting the novel coronavirus known as COVID-19 or any mutation or variation thereof.
 - vi. In addition, I hereby voluntarily agree to RELEASE, WAIVE, DISCHARGE, and COVENANT NOT TO SUE AASB (and/or its officers, directors, and employees), and any individuals, companies, or associations having anything to do with the EVENT, including but not limited to participants,

officials, and owners of the premises where the EVENT takes place (collectively referred to as "RELEASEES"). By signing this document, RELEASEES WILL BE RELEASED FROM ANY AND ALL LIABILITY for any and all loss or damage whether caused by the negligence of the Releasees or otherwise related to possible exposure to or contracting of the novel coronavirus known as COVID-19 or any mutation or variation thereof; and

- vii. I hereby agree to INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage, or cost (including reasonable attorney's fees) they may incur arising out of or related to my illness or death whether caused by the negligence of the Releasees or otherwise.

BY CHECKING THE BOX, YOU AGREE THAT YOU HAVE READ AND UNDERSTOOD THIS WAIVER AND RELEASE, AND AGREE TO BE BOUND BY ITS TERMS.
